<b>Self-isolation &lt; 18 years and 6 months</b>	From 16 August children under the age of 18 years and 6 months will <b>no longer</b> be required to self-isolate if they are a close contact. They are advised to take a PCR test.  However they <b>do need to self-isolate if they live in the same household</b> as someone with Covid-19 symptoms or with someone who has tested positive.	✓	SC/ST	Close contact definition: <ul style="list-style-type: none"> <li>face-to-face contact under 1 metre for any length of time – including talking to them or being coughed on</li> <li>being within 1 metre of each other for 1 minute or longer</li> <li>being within 2 metres of each other for more than 15 minutes in total in 1 day</li> </ul>	16/08  23/7

<b>Covid-19 symptoms or positive test</b>	No one should come into school if they have symptoms or have had a positive test result. Anyone in your school developing Covid-19 symptoms, however mild, should be send home. 	If a parent or carer insists on a pupil attending your school, you can take the decision to refuse the pupil if, in your reasonable judgement, it is necessary to protect other pupils and staff from possible infection with COVID-19. <b>Positive LFD</b>	Everyone with a positive LFD test should self-isolate, they will also need to get a PCR test to check if they have Covid-19. While waiting for the PCR result the individual should continue to self-isolate. If a pupil has a positive lateral flow test and then has a negative PCR test within 2 days of the positive Lateral flow result then the PCR test result overrides the self test Lateral flow result and they can return to school as long as they aren't displaying any Covid -19 related symptoms. <a href="#">School should seek public health advice if anyone in their setting has been admitted to hospital with Covid-19.</a>	✓	SC/HO	Isolation period is 10 days. <b>Outbreak Management Plan</b>	<p>If you have several confirmed cases within 14 days, you may have an outbreak.</p> <p>In the event of a Covid outbreak within a school setting Public Health will advise on a case by case basis whether or not additional measures are required and will identify what these measures will be.</p>	✓	SC	<p>All schools should have an outbreak management plan. Any measures should be kept to the minimum number of groups possible and for the shortest time possible.</p> <p>Use Covid Outbreak Management Plan <b>along with the detailed school plan. <b>Good hygiene</b>	You should continue to ensure that pupils clean their hand regularly “Catch it, Bin it, Kill it” continues to be very important for respiratory hygiene.	✓	SC	Make sure that you have hand towels and handwash checked and replaced as needed. Check hand sanitiser.	23/7
<b>PPE</b>	Most staff will not require PPE beyond what they would normally need for work.	✓	SC		23/7
<b>Cleaning</b>	You should maintain an appropriate cleaning schedule. The guidance advises on two cleans per day but this is a minimum requirement and some areas may require cleaning more thoroughly depending upon use and pedestrian flow. <b>Ventilation</b>	It is important to ensure that rooms are well ventilated and that a comfortable teaching environment is maintained. You should identify any poorly ventilated spaces and take steps to improve fresh air flow in these areas, giving particular consideration when holding events where visitors such as parents are on site, for example, school plays.  Inform parents if you relax school policy to allow for pupils to wear warm in colder months.	✓	SC/AL	Opening external windows can improve ventilation, and in addition, opening internal doors (not fire doors) can also assist with creating a throughput of air. You should balance the need for increased ventilation while maintaining a comfortable temperature. Windows will be opened more fully during breaks to purge the air in the space.  Consider using CO2 monitors to check air quality in poorly ventilated rooms. <b>LFD testing (staff)</b>	Staff should undertake twice weekly tests at home until the end of September when this will be reviewed. All staff must report their results to NHS Test and Trace.	✓	SC		Review September

<b>LFD testing (secondary students)</b>	All secondary students should receive 2 on-site lateral flow tests, 3 to 5 days apart on their return in the autumn term. <b>Remote education</b>	Schools should maintain capacity to deliver high-quality remote education for the next academic year. <b>International visits</b>	You should be aware that the travel list (and broader international travel policy) is subject to change and green list countries may be moved into amber or red.
